1. Unlimited golf and use of practice facility Monday – Friday anytime, weekends & Holidays after 12 PM.
2. Second Junior Member must be an immediate family member.
3. Cart fee is \$14 per person per 18-hole round.  
*(If Junior wishes to use cart they must be accompanied by adult if they don't possess valid driver's license)*
4. USGA Handicap.
5. Member must check-in at the golf shop prior to playing golf or using practice facility.
6. Membership valid for one year from the date membership is paid.
7. Twenty-four hour cancellation notice required for reserved tee times.
8. Proper course etiquette as defined by the USGA is required while on the golf course and grounds.
9. Proper golf attire must be worn on club grounds.
