All parties hereto agree to the following terms and conditions:

**Membership Program:**

5 Year Platinum *Plus* Membership (*Effective for 5 years from above date*)

**Membership Privileges:**

1. Unlimited Green Fees with Cart & use of Practice Facility
2. USGA Handicap
3. 30-day Advance Tee Times
4. Monthly guests, merchandise & food service billing available
5. 10% discount on all pro shop non-sale items

**Club Rules:**

1. Member must sign in and register prior to golfing.
2. Twenty-four hour cancellation notice required for reserved tee times.
3. Mutual respect and courtesy between all members, staff and other golfers.
4. Proper course etiquette required with respect to the course and grounds.
5. Proper golf attire must be worn on club grounds.

**Membership Billing:**

1. Member may charge guest(s) fees, merchandise & food service charges to their A/R account with member’s credit card on file paid on the 1<sup>st</sup> of each month for the prior month’s charges.

**Indemnification and Assumption of Risk:**

By executing this Agreement, Member hereby agrees to indemnify, defend and hold Worthington Manor Golf Club (and their respective owners, directors, partners, officers, operators, employees and other agents) harmless from and against any and all liabilities, costs (including reasonable attorney’s fees), claims, demands or damages incident to or arising out of or relating to the acts or omissions of Applicant, their Family or guest(s), and their respective use or occupancy of the Facilities. In addition, by executing this Agreement, Member hereby voluntarily assumes all risks of accident or damage to Applicant’s person or property, and the person or property of Applicant’s Family and guest(s), arising out of or relating to the use or occupancy of the Facilities.

Furthermore, the Member hereby agrees that any blatant infractions or abuse of the rules the club, could result in suspension or immediate termination of the membership without refund.
