Membership Details & Club Rules:

1. Unlimited green fees and use of practice facility anytime Monday through Friday and after 12 PM on weekends and holidays.
2. Cart fee additional (currently \$14 per person per 18-hole round).
3. Member receives \$10 discount off weekend/holiday rates before 11 AM.
4. USGA Handicap service and 21-day advance tee times.
5. Member must check-in at the golf shop prior to playing golf or using practice facility.
6. Membership valid for one year from the date of this agreement.
7. Twenty-four hour cancellation notice required for reserved tee times.
8. Proper course etiquette required with respect to the course and grounds.
9. Proper golf attire must be worn on club grounds.
10. Member must keep a current credit card on file for monthly membership dues and on-account charges.

Membership Billing:

1. Members in good standing may charge guest fees, merchandise, food service and cart fees.
2. Member must keep a current credit card on file for monthly dues payments and/or charges to their A/R account.
3. Member charges and monthly dues are invoiced on the 15th of each month and are due on the 1st of each month.
5. Balances not paid by the 15th of each month will be charged a finance charge equal to annual percentage rate of 12%.
6. Members who select monthly payments are committing to a minimum of 12 monthly payments.

Indemnification and Assumption of Risk:

By executing this Agreement, Applicant(s) hereby agrees to indemnify, defend and hold Worthington Manor Golf Club (and their respective owners, directors, partners, officers, operators, employees and other agents) harmless from and against any and all liabilities, costs (including reasonable attorney's fees), claims, demands or damages incident to or arising out of or relating to the acts or omissions of Applicant, their Family or guest(s), and their respective use or occupancy of the Facilities. In addition, by executing this Agreement, Applicant hereby voluntarily assumes all risks of accident or damage to Applicant's person or property, and the person or property of Applicant's Family and guest(s), arising out of or relating to the use or occupancy of the Facilities.

The applicant(s) agree that the Club Rules are a general understanding and other rules and regulations may be instituted or implemented. Furthermore, the Applicant(s) hereby agree that any blatant infractions or abuse of club rules could result in suspension or immediate termination of the membership without refund.
